Different Ways to Participate

- Broadway (or nearby streets) Business. For businesses on or near Broadway in Stowe.
- Guest Vendor. This option is for those who don't have a business on or near Broadway but would like to sell their art, craft, food, or other products. You can apply as a Guest Vendor to participate as a guest in a Broadway or nearby street storefront or in a pop-up on the street.
- Guest Participant. This option for those who don't have a business on or near Broadway, but would like to provide information about your business or organization or free samples of your products. You can apply as a Guest Participant to participate as a guest in a Broadway or nearby storefront or in a pop-up on the street.

Fees: There's a \$10 Vendor Fee payable to Stowe Township. *This fee applies to Guest Vendors only.* It is a Stowe Township requirement. Broadway (or nearby streets) Businesses and Guest Participants do not have to pay the fee. Guest Vendors must provide proof of payment to participate. More info on page 2.

Images: We'll be doing a lot of social media to promote the event. We'll provide the option for you to upload photos of your business, art, products, etc. that we'll use in our posts. We also encourage everyone to promote the event on their own social media pages as well.

Canopies & Displays: Guest Vendors and Participants will provide their own display set-up such as a canopy (for street pop- ups), display panels, tables, chairs, etc. Some of the businesses that are hosting Guest Vendors and Participants may have tables and chairs available to use. *All businesses, vendors, and participants must be present/open for the entire show.* No early breakdown/closure allowed without promoter's approval.

Application Deadline: Applications must be received **no later than August 26, 2019.** We're creating a digital and printed map for the public to use at the event. We need plenty of lead-time to produce and distribute it. If we receive your application after the deadline we cannot guarantee that your business/organization will be shown on the map or other print marketing materials.

Email Notification: All correspondence from us will be by email. If you don't have an email address, please provide one that you can access easily. We'll email you upon receipt of your application and again about a week before the event with instructions, directions, parking info, etc. You're required to email acknowledgment of your receipt of these emails. Other communications about the event will also be by email.

Marketing for Ringin' the Rocks: We'll have a large banner over Broadway. We'll distribute color posters throughout Stowe Township and McKees Rocks and beyond. We'll do extensive social media and email marketing. Our first event in June was well attended and we got a very positive response from the people attending.
